





ARCHIVES AND JUSTICE: A South African Perspective is a collection of 20 essays and 16 newspaper articles written by Verne Harris between 1994 and 2005. Throughout this extraordinary collection Harris explores two intersecting nexuses—archives and justice, and South Africa and a wider world. Drawing on the energies of Destribution, he suggests an ethics and a politics that are by Terry Cook introduces Harris and his work to a wider readership:

He is also the author of two novels, both of which were short-listed for Terror Country Country


