SUMMARY

Dr Jane Kelly is Senior Research Officer at the Centre for Social Science Research, University of Cape Town where she is the lead qualitative investigator for a mixed methods longitudinal cohort study which explores protective pathways to promote resilience amongst adolescent parents and their children in South Africa. She was one of four awardees of the UCT Grand Challenges Pilot Programme in 2023. Since 2018 her work has culminated in 16 peer reviewed journal articles, 324 citations, an h-index of 11 and an i10-index of 12. She has a background in research psychology, and experience working in both academic and government settings, including experience in developing and evaluating training programmes for teachers of children with disabilities. Her current work is largely focused on co-developing research to inform effective policy implementation, and her research interests include supporting pregnant and mothering adolescents return to school and access healthcare services, as well as supporting the resilience of young people more broadly.
