Jeremy Seekings is Professor of Political Studies and Sociology and Acting Director of the Institute for Democracy, Citizenship and Public Policy in Africa at the University of Cape Town. From 2012 to 2023 he was Director of the Centre for Social Science Research at UCT. He is currently a Visiting Professor at Princeton and has previously been a Visiting Professor at Yale and Princeton. His published work ranges across history, political science, sociology and economics. His books include: The UDF (2000); Class, Race and Inequality in South Africa (2005/2006) and Policy, Politics and Poverty in South Africa (2015) and Inclusive Dualism: Labour-Intensive Development, Decent Work, and Surplus Labour in Southern Africa (2019) (all with Nicoli Nattrass); and the multi-authored Growing Up in the New South Africa (2010). He coedited *The Politics of Social Protection in Eastern and Southern Africa* (2019) and 12 special issues of journals. He edited the African Studies journal Social Dynamics (2001-2006), co-edited the International Journal of Urban and Regional Research (2005-11), serves on the editorial board of Global Social Policy and is an 'international editorial adviser' to the Journal of Social Policy. His current research focuses primarily on the politics of welfare policy reform both historically and in contemporary Africa (as well as in the Caribbean and Mediterranean), and on party politics and voting behaviour in Southern Africa (primarily in Botswana and Zambia). His research has been funded by (inter alia) the UK's former Department for International Development, the Andrew Mellon Foundation, the Rockefeller Brothers Foundation, the Friedrich Ebert Stiftung, the World Bank, the Volkswagen Foundation, the European Union and the US National Institutes of Health. He also directs the University of Cape Town's support for the Afrobarometer network of public opinion surveys.
